19. Standard installation rates set forth are based upon the following terms and conditions:
- Installation services are customer approved per the bill of materials and specifications
  - Inside delivery, uncrating, assembly and installation of furniture
  - Removal of all debris from premises to customer provided repository
  - Installation occurs during normal weekday business hours, Monday through Friday from 8 AM to 5 PM local time, excluding weekends and holidays
  - Installers will perform a final walk through inspection to note any warranty work or parts needed
  - The installation area must not be hindered by other trades. Customer is responsible for providing job ready site, an area free of debris for unloading, moving, storing and staging products during the installation time frame
  - Necessary electric, accessible elevators and docks are provided by the customer at no charge
  - Any work requiring the installation of data/telecommunications or a licensed electrician will be the responsibility of the customer.

Conditions that may affect the overall installation rate:

- Union labor and/or prevailing wage rates, overtime, holiday and weekend hourly rates
- Restricted access to building, including but not limited to security clearance, job site requirements, escorts, etc.
- Additional personnel costs such as obtaining permits, identification cards, etc.
- Engaging a US Citizen driver with proper documentation for transportation requirements
- Nonstandard working conditions and restrictions such as stair carry, limited elevator access, dock restrictions, truck- or trailer-size restrictions, etc.
- Conflicts, scheduling limitations or delivery changes caused by customer, other contractors, other trades, rush delivery, building delays, etc.
- Site preparation
- Removal or disposal of existing products
- Product storage
- Installation outside of a 50-mile radius of the servicing dealer
- Installation in a clinical/medical environment

Additional charges shall be quoted on a project-by-project basis by an authorized Global dealer and approved by the customer prior to performance of work.

Prompt payment discounts are not applicable to installation services. Additionally, please note that installation charges do not count toward product volume pricing tiers.
